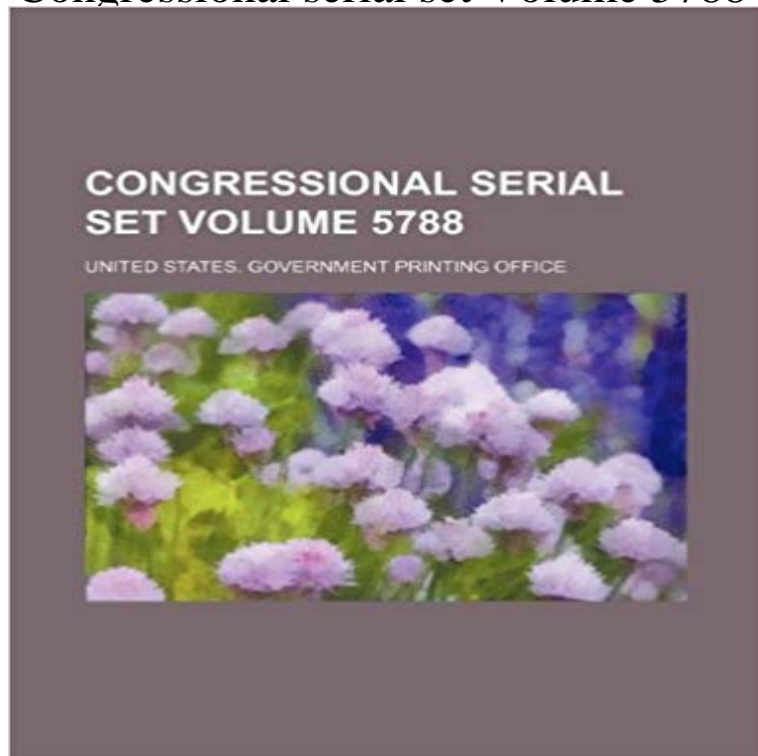

Not illustrated. 1910 Excerpt: ...It is difficult to see why a conviction and punishment under an unconstitutional law is more violative of a persons constitutional rights, than an unconstitutional conviction and punishment under a valid law. In the first case, it is true, the court had no authority to take cognizance of the case; but in the other, it had no authority to render judgment against the defendant. This was the case of *Ex parte Lange*, where the court had authority to hear and determine the case, but we held that it had no authority to give the judgment it did. It was the same in the case of *Snow*; the court had authority over the case, but we held that it had no authority to give judgment against the prisoner. He was protected by a constitutional provision, securing to him a fundamental right. It was not a case of mere error in law, but a case of denying to a person a constitutional right. See, also, *In re Frederick*, 149 U. S., 70-76: *In re Bonner*, 151 U. S., 242-256. Convinced that the court was without authority to make the only order which the defendants *Gompers* and *Morrison* can be said to have disobeyed, I can have no other opinion than that the decree should be reversed.
